



# 2011-12 LIFE CHRISTIAN ACADEMY TRANSPORTATION COMMITMENT

This agreement between Life Christian Academy and the family listed below is a commitment to follow all guidelines and direction for bus use. If there is a reason for discontinued use of the service, please notify the Life Christian Transportation Office.

- This service is provided for registered riders only.
- Children will be dropped off at the designated bus stop and are no longer the responsibility of Life Christian Academy. Please have someone there to pick up your child.
- Bus Drivers **must** leave the stop FIVE minutes after the designated pickup/drop-off time.

### PLEASE SELECT ONE OPTION OF SERVICE

**OPTION 1 – Full Ridership Privileges**- Families will be charged \$75.00 per calendar month that a student wishes to ride the bus. If a family will have more than one student riding the bus, the monthly charge for the entire family will be \$100.00. This option is available on monthly basis (September – May) and will be charged to your student’s account. If they ride any part of the month, the monthly charge will be incurred.

**OPTION 2 – Bus Ride Punchcard** – Families can purchase a 25 ride punchcard for their student’s use whenever the need occurs to use the bus system. This card can be purchased for \$75.00 from the Business Office and will be kept on the designated home bus. If the student needs to ride a different bus, arrangements will need to be made ahead of time with Transportation Department.

**OPTION 3 – Per Ride Charge** – A student can purchase a single bus ride pass for \$5.00 from the Business Office. A parent signed bus permission slip must be presented with cash or check to receive the ticket to use the bus. It will not be possible to charge an account or credit card for this option.
